- Security Staff should be medically and physically fit.
- Every guard will be equipped with weapon & ammunition.
- In case, guard do not meet above criteria or produce disciplinary problem will be replaced immediately.
- The selected bidder will provide two uniforms (wet weather/winter/summer) clothing to each guard.

**Past Experience and Certifications:**

Firms having at least five (05) years relevant experience in dealing with similar nature of work and having valid **Active Tax payer certificate**, (BST/GST & Income Tax registrations certificates) are eligible to participate (please attach company profile/ certificate of reputation and copies of BST/GST & Income Tax registration certificates with the tender form).

**IMPORTANTS:**

- Firms are required to quote all rates in Annex A;
- Incomplete or partial bids will not be entertained and will be considered non-responsive and will be rejected;
- **Rates should be inclusive of all taxes.**
- Escalation of rates under whatsoever circumstances is not allowed;

- **Vendor should have valid Income Tax, BST and GST certificate (if applicable). If a vendor fails to provide such documents, the company will be rejected directly without further processing the evaluation of the technical offers.**

**CONTRACT TIME:**

Contract with successful firm will be initially for one year and may be extended for further one year with mutual consent of both parties.
